l.	Introduction	 A. Director's Report 1. Alfred shared that the Spring semester is beginning with full classes. 2. Wait lists continue for ESL with hundreds currently on the list. 3. Alfred also announced that the CNA program continues to be on hold pending state approval. 		
II.	Public Comment	A. Community Comments 1. No comments were submitted or presented.		
III.	Minutes	A. Approval of Minutes 1. Minutes for January 18, 2024 were presented and approved by the Board.		
IV.	Strategic Planning	A. Labor Market Information 1. MaryAnn conducted a presentation on the labor market focusing on healthcare and the continued demand for occupations in the industry.		
V.	Partner Updates	A. Partner Updates 1. GYA: Laura announced that the STEP paid work experience program was underway for youth and young adults (ages 16-21) with disabilities. Any Garfield student that has a disability and is within the age group can be referred to Laura. a. Laura also shared that Garfield students, ages 18-24, are also eligible for paid work experience. Any Garfield student within this age group can be referred to Laura if they are interested in internships, externships, part-time and full-time work.		



 VWDB: Judith announced the success of the Health Fair just held at the VJC and shared that the next fair would be held on February 13th focusing on manufacturing jobs. VJC: Ani reported that the healthcare job fair was a success with 10 employers and 200 job seekers. She also noted that a second job fair was held for an aerospace company, Senior SSP Aerospace,

that had 70 openings.
b. Ani reported on the status of the medical assistant paid externships: 8 are currently enrolled, 4 completed their externships and 4 are still working. Of the 8 so far, 1 extern was asked to stay on by the employer.
4. IRC: Hilda reported that they are still very busy with refugees coming in from different countries. IRC is offering a series of citizenship workshops at libraries located throughout Los Angeles. a. Hilda also noted that New American Initiative Immigration/Citizenship services are well underway.
5. GCC ESL: Naomi reported that more than 3,000 Russian and Ukrainian refugees are enrolled at Garfield. Instructors are seeing less Spanish speaking immigrants.
6. DOR: Jonathan reported that they continue serving people with disabilities and are seeing an increase in those with Post Traumatic Stress Disorder (PTSD) and depression.
7. JVS : Alees announced that a new policy was released to continue the housing and utility assistance for Ukrainians. Applications are being accepted now and the program will continue through September 2024. a. Alees also reported that they continue to receive new cases for new refugees and are providing full services including supportive services.

Emotional Hijack: How to Not Take Things Personal!

Summary: The ability to keep our emotions under control requires more than a willing heart. It requires self-management and self-awareness skills. Our specific manner of comprehending situations dictates our subsequent reactions. This training explores the root cause of emotional highjack and how to deal with it. Will explore the "Why" behind many of the learned behaviors and emotions. Learn the different ways your brain processes information and the automatic interpretations we make to daily events. Explore and understand our reactions and the direct relationship of our thinking and feeling.

The LIFERAP program provides case management and wrap around services to improve the quality of life of Glendale families by providing rental and employment assistance for low income, working households.

Eligibility Requirements:

- Must be a Glendale resident
- Currently residing in a rental unit
- Have one or more children under the age of 18 Minor must be 18 or younger at the time of application
- Must have Right to Work documents
- At least 1 family member must be working 32 hours a week or more
- Must be willing to commit to the program for 12 months;
 meet with case manager monthly; open a saving plan; provide all necessary documentation
- Cash aid (CalWORKS) recipients are not eligible for the program





- Debe estar dispuesto a comprometerse con el programa durante 12 meses;
 reunirse con el administrador de casos mensualmente; abrir un plan de ahorro;
 proporcionar toda la documentación necesaria
- Los beneficiarios de asistencia monetaria (CalWORKS) no son elegibles para el programa


